PROPOSALS WILL BE ISSUED ONLY TO AND ACCEPTED FROM CONTRACTORS ON THE ALABAMA DEPARTMENT OF TRANSPORTATION'S (ALDOT) LIST OF PRE-QUALIFIED CONTRACTORS. THE AWARD OF THE CONTRACT WILL BE MADE ONLY TO A CONTRACTOR WHO HAS A VALID CERTIFICATION OF QUALIFICATION FROM ALDOT AS REQUIRED BY STATE LAW AND WILL NOT BE MADE TO ANY BIDDER WHO IS CONSIDERED BY ALDOT TO BE DISQUALIFIED FROM BIDDING, OR IS AN AFFILIATE OF OR HAS A CORPORATE OFFICER, DIRECTOR, OR PRINCIPAL OWNER WHO IS A CORPORATE OFFICER, DIRECTOR, OR OWNER OF, ANOTHER PERSON WHO IS PRESENTLY DISQUALIFIED BY ALDOT.
