Sealed bids will be received until **Thursday, October 10, 2024 at 2:00 PM EST** at the Bulloch County Commissioners Office located at 115 N. Main Street, Statesboro, Georgia 30458 and at said time bids will be publicly opened and read aloud for furnishing all labor, materials and equipment and performing all work necessary for the: **Apron Rehabilitation** at the **Statesboro - Bulloch County Airport**. Major items of work include: a **Base Bid** for pavement rehabilitation on the Main Apron with milling, joint and crack seal, and overlay. In addition to the Base Bid, there are two (2) other areas of work (Add Alt 1 and Add Alt 2) that will be considered for award as a part of this project as well. **Add Alt 1:** Emulsified asphalt slurry seal for the T-Hangar aprons on the west side of the Main Apron and two smaller hanger aprons on the south side of the Main Apron. **Add Alt 2:** Full depth pavement repair for the apron on the east side of the Main Apron.

A PRE-BID Meeting is scheduled for **Monday, September 23, 2024** at 2:00 PM EST at the Statesboro - Bulloch County Airport terminal building located at 601 Airport Blvd., Statesboro, Georgia 30461. Attendance is non-mandatory, but encouraged.

Each proposal must be accompanied by a bid guaranty in the amount of five (5%) percent of the total amount of the bid. The bid guaranty shall be a bid bond made payable to Bulloch County Board of Commissioners.

Bids may be held by Bulloch County Board of Commissioners for a period not to exceed one hundred twenty (120) days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.
