"A contractor must have a Heavy and Railroad major license or a Heavy and Railroad specialty license to bid as prime for this project."

Bids may be held by the Florala Municipal Airport Authority for a period not to exceed one hundred twenty (120) days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.
